There will be two exams. Each counts 45% of your final grade. The second exam is taken during the final exam period and may include some of the material (the parts I feel the class did not perform well on) from the first exam in addition to the new material covered after the first exam. Due to a large number of students in the class, the exams possibly will consist mostly of multiple choice questions. You are encouraged to have a calculator with you during the exams. You may also take a self-prepared formula sheet (A4 paper) to the exams. You will be seated in a particular order for the exams. Your seat will be made known to you right before the exam begins. The remaining 10% is determined by your participation in the class discussion and ad hoc assignments. Homework problems will be assigned, but not collected for grading. I will post on the website the solutions manual to the end-of-chapter problems in the book. I suggest that you complete as many end-of-chapter questions and problems as possible. You can expect to be called upon frequently in this class. You are responsible for all lectures, assignments, and class discussions. I encourage you to form groups of 2-3 people to work on the end-of-chapter questions, problems and cases. No late assignment or exam is accepted unless permission is granted beforehand under very unusual circumstances.
